- ☑ The Alliance—through our Research Department—maintains an online database of regional commercial properties. We use this information and our partnerships with utilities to fulfill LED Requests for Proposals
- ☑ The Alliance worked with industry leaders to facilitate major company relocations and expansions like the Sasol Ethane Cracker project which will mean 8,100,000,000 in investment and 904 jobs (direct and indirect), the Cheniere Energy and Cameron LNG projects which will bring in a combined 20,310,000,000 in investment and 1,087 jobs (direct and indirect) and the Magnolia LNG project which can bring in 4,354,000,000 in investment.
- ☑ Over the past few years, RFPs and visits with site consultants and prospects have resulted in \$108 billion in announced and new projects under construction and approximately 5,800 new jobs.
- ☑ The Alliance is working throughout the region on developing Louisiana Economic Development (LED) Certified Sites.

- ☑ The Chamber employs a lobbying firm—The Picard Group—who advocates for the business community of Southwest Louisiana.
- ☑ Through our Public Policy work, we connect business owners and managers to regional elected officials to facilitate business friendly legislation.

- ☑ The Alliance makes site visits throughout the year to monitor the needs and roadblocks faced by regional industry. Last year, we made 51 business retention and expansion calls.
- ☑ The Alliance is currently working on several workforce development initiatives to address the need for skilled workers in the area.
- ☑ We have facilitated the funding of 13 regional elementary schools to participate in The Leader in Me program which improves students ability to learn and lead throughout their lives.
- ☑ The Alliance and Chamber both provide many opportunities for professional and entrepreneurial development, offering classes, workshops, and training programs.
